MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on the 9th day of December 2019.

BETWEEN

Shri Swami Bhumanand hospital having its hospital at Jawalapur, Haridwar, herein referred to as "**Provider**" which expression shall unless repugnant to the context or meaning thereof be deemed to mean and include its successors and assign "**Shri Swami Bhumanand Hospital**"

AND

Gurukula Kangri Vishwavidyalaya hereinafter refereed as "**GKV Haridwar**" having its registered office at Haridwar, Uttarakhand India herein after referred to as "**Recipient**" which expression shall unless it is repugnant to the context or meaning thereof be deemed to mean and include its successors.

Whereas, **GKV Haridwar** has approached **Shri Swami Bhumanand Hospital**, for providing medical services to the employees (Permanent / Contractual/ Daily Wages) and their dependents as well as students of **GKV Haridwar**. **Shri Swami Bhumanand Hospital** agreed to provide medical services to the employees (Permanent / Contractual/ Daily Wages) & their dependents and students of **GKV Haridwar** visiting **Shri Swami Bhumanand Hospital**.

Both parties do hereby agree the following:

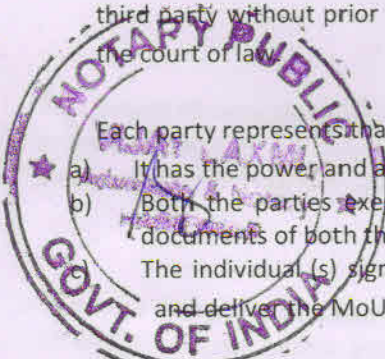
This MoU is valid initially for two years from the date of acceptance and signing it. Then after it will be continue for the next period after mutual consent of both the parties.

1. Shri Swami Bhumanand Hospitals agrees to provide all diagnostic services, treatments, consultations, hospital admissions and other procedures for OP & IP visits and during emergencies to employees (Permanent / Contractual/ Daily Wages) & their dependents and students of GKV at discounted rates on normal hospital's tariff.
2. Shri Swami Bhumanand Hospital will provide the following discounts for GKV employees (Permanent / Contractual/ Daily Wages) & their dependents and students.
 - a. Corporate Cash discount of 15% on OP investigations, procedures & diagnostic services
 - b. Corporate discount of 15% for IP in cash for (Bed Charges, investigation & procedures) the beneficiaries of the **GKV Haridwar**
 - c. ID card issued by the **GKV Haridwar** administration will be taken as proof and a letter from Registrar – GKV should be provided within in 24 working hours in case of emergency admission. The above offers are extended for employees, students, workers, their dependents with appropriate identity proof to link with the employee/s. The authority letter is mandatory for the application of discount.
 - d. Free pick up and drop will be provided only in case of admission of patient. Emergency calls can be attended for free (refer close no 9) within 10KM from the radius of Swami Bhumanand Hospitals for all beneficiary of **GKV Haridwar**
3. Billing status of different category of the beneficiaries from GKV are regulated as below:
 - a) In-case of permanent employee or their dependents: Payment shall be made from the **GKV Haridwar** based on entitlement of the beneficiaries as per the UGC/ Govt. of India rules & regulations.
 - b) In case of the contractual/ daily wages employees/ students of the **GKV Haridwar**: Payment shall be borne by the beneficiary through the self or any medical coverages empaneled with the hospital.
 - Note: Students of GKV have medical coverage of Rs. Two Lakhs from the Star Health Pvt. Ltd.
4. Shri Swami Bhumanand hospital can organize and conduct free health camps (once in 6 months), Paid Health Check-ups (*on rates approved in time to time*) and paid Health Education programs (*once in 6 months*) for all the beneficiaries in the **GKV Haridwar** premises.
 - a. This process could be initiates by any of the party and planning of the event can be only freeze after the mutual consent of both the parties.
5. The beneficiaries will have to present their ID card to avail the corporate benefits enclosed at Shri Swami Bhumanand Hospital.
6. All authorization letters should be authorized by the Registrar – Gurukula Kangri Vishwavidyalaya. All the credit bills of **patient** will be forwarded on last day of the month and the bills should be cleared will in 30 working days (of the bill date). Any delay in payment with attracts 18% interest.
7. **Shri Swami Bhumanand Hospital** and **GKV Haridwar** personnel will be abiding the rules and regulations mutually agreed upon. Any breach of the same shall be brought to notice of **Shri Swami Bhumanand Hospital** and **GKV Haridwar** authority as the case may be and there shall be no direct conflict with the concerned employee/s.

- 8. In case of emergencies, the concerned beneficiary will have to produce the authorization letter within two working days to **Shri Swami Bhumanand Hospital**.
- 9. Ambulance will be provided by **Shri Swami Bhumanand Hospital** to pick up patients during emergency at totally free of cost till the radius of 10 KM from the hospital. Then after Rs. 15/- per KM will be charged from the patient in case of refer, shifting to home or in any other situation.
- 10. This MoU shall come into force from the date mentioned hereof. Either party may terminate this MOU upon 30 days' notice in writing to the other party in event of material breach by either party of the terms hereof, the other party may terminate this MoU with immediate effect.
- 11. Either party shall not transfer its rights or obligations in any manner what so ever without the prior consent of the other.
- 12. The parties agree that the terms and conditions of this MoU are confidential and shall not be disclosed to any third party without prior written consent from the non-disclosing party, unless such disclosures are required in the court of law.



Each party represents that:

- a) It has the power and authority to enter the MoU and perform its obligations hereunder.
 - b) Both the parties execute this MoU so long as it is not inconsistent with the laws and other constituent documents of both the parties.
- The individual (s) signing this MoU on its behalf, whose name appears below, has the authority to execute and deliver the MoU.





