The parties hereby agree to establish collaboration according to terms and conditions set out in the articles following hereunder.


Article I: Background

This MoU will submit to the Institute of repute that work in the field of industry related training and arrange course for engineering students through which they can learn about special software as per their academic requirements.


Article II: Scope of Collaboration

The general purpose of this MOU is to facilitate Institute and cooperation between the parties hereunder based upon the principles of mutual benefit and may include the following general cooperation areas.

- Joint Institute -Academia and training programs.
- 2. Specific activities under this MOU will identified through consultation between the two parties. CAD DESK agrees to provide specific assistance to Faculty of Engineering & Technology improving recruitment of their students with the use of their innovative solution. CAD DESK will try with their clients to bring openings on its solution and all eligible students of Faculty of Engineering & Technology will participate for job interviews on the platform from their campuses.
- Discussion for the exchange of facilities and equipment for collaborative or independent training program based on the policies of both entities.
- 4. Training to the students as per their curriculum.




- 5. Participation of industry experts in curriculum design.
- 6. The fees decided mutually may be charged from the student and there is no involvement from institute side. All fee must be pre decided and there is no other hidden charges shall be payable.
- 7. Classes will be conducted in the FET campus only and during the college working hours, if possible.
- 8. The college will provide the infrastructure, computer lab, LCD projector & shall depute a lab assistant cum managerial level person, who will monitor these training in the campus.
- 9. Training programs that is conduct primarily for the students of Mechanical Engineering. Students from other branches may also join as per their interest or requirement
- 10. CADDESK will provide Course Completion Certificate (It can be verified online) as well as reference study Books to the students. Certificate must have the branding of both the parties.
- 11. Total training hours depend upon the appropriate training programs, i.e., 24 hours and 48 hours approximate. Both the parties mutually agree on the duration as per students' requirements.
- 12. For GKV students, CADDESK and FET authority mutually fix the training cost on situation basis.
- CADDESK will take all the responsibility to install the software & prepare lab for the training purpose.
- 14. A representative of CADDESK must be appoint for fee collection from the student's side and generate a fee slip for student's reference.
- 15. Authorities of both the parties mutually decide the facility charges to GKV before every training program. CADDESK have to the decided amount to Vishwavidyalaya against the facility charges through cheque/DD in favour of Registrar, Gurukula Kangri Vishwavidyalaya, Haridwar.
- 16. All the concerning Department will keep copy of MOU for the reference.



17. CADDESK will be allowed to conduct technical présentation periodically for registered students only. CADDESK will be allowed for promoting their course inside the FET campus only.

ARTICLE III: General Terms & Conditions

- This MOU is not intended to, and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable at law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents.
- 2. This MoU is solely work for the development of students, faculty, institute executives and staff provides self-employment, training and skill development.
- Nothing in this MOU obligates either party to commit or transfer any funds, assets, or other
 resources in support of projects or activities between the parties unless expressly stated in
 this agreement.
- 4. Both parties agree to submit outcomes of their joint collaboration, whilst safeguarding their own copyright and any patents that may produce by their collaboration.
- The activities of this MOU must carry out in accordance with appropriate laws and regulations existing in India.
- This MOU shall be operational upon signing and will have an initial duration of two years. All
 activities conducted before this date within the vision of the joint collaboration will deemed
 to fall under this MOU.
- 7. In order to carry out and fulfil the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities.
- 8. Each party agrees that after execution of the MoU, shall not disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.
- 9. The partnership covered by this MOU shall terminate upon completion of the agreed upon period. The agreement may also terminate with a written one-month notice from either side. In the event of noncompliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.



- 10. All notice, demands and other communication under this agreement in connection herewith shall written in English language and shall sent to the last known address, email, or fax of the concerned party. Any notice shall be effective from the date on which it reaches the other party.
- The activities of this MOU must be carry out in accordance with appropriate laws and regulations existing in India.
- 12. Faculty of Engineering & Technology will promote ethical practice among students and encourage them to conduct ethically during their trainings and jobs in the company.

The Agreement

- 1. At Faculty of Engineering & Technology, Dean- FET will administer this MOU.
- The parties may enter into specific written agreements under authority of this MoU to clarify and define the nature, extent and terms of operation for the proposed collaborations, including intellectual property ownership and funding issues.
