# MEMORANDUM OF UNDERSTANDING

between

and

**GURUKULA KANGRI VISHWAVIDYALAYA, HARIDWAR**

NATIONAL INSTITUTE OF TECHNICAL TEACHERS' TRAINING AND RESEARCH, KOLKATA (hereinafter referred to as "NITTTR-K") which expression shall include its legal successors and/or permitted assigns of the other part and GURUKULA KANGRI VISHWAVIDYALAYA, HARIDWAR (hereinafter referred to as "GKV"), which expression shall include its legal successors and/or permitted assigns of the other part hereby agree to sign a Memorandum of Understanding (MoU).

Both the above being hereinafter collectively referred to as the "Parties".

## 1.0 BROAD OBJECTIVE

**Recognize** the mutual interest in the field of joint teaching, training and other related activities and dissemination of knowledge.

**Recognize** the importance of other institutions role in creating the number of placement opportunity, Faculty Development Programme, Staff Development Programme and other activities.

## 2.0 SCOPE

NITTTR-K shall provide support to GKV in developing quality teaching-learning process in Undergraduate, Post-Graduate (including doctoral) teaching programmes in various engineering and allied disciplines.

### 2.1 UG & PG Teaching

GKV would endeavour to enhance the quality of UG/PG teaching in science/ engineering and allied disciplines in order to bring it at par with the best in the country with support from NITTTR-K.

### 2.1.1 UG Teaching

The scope of the MOU shall cover the following items:

- i. NITTTR-K shall help GKV in Development of Faculty of its Constituent/Affiliated institutions through its existing training programmes in the areas of content updating & professional skill development. Further, if required by GKV, other such specific programmes shall be worked out jointly on project mode.
- ii. NITTTR-K shall provide access to GKV the resource materials on electronic/print media, to be selected jointly.
- iii. NITTTR-K shall provide GKV or its authorized person on-campus access to its Central Library as per existing provision of NITTTR-K.

### 2.1.2 PG Teaching Programme

- i. NITTTR-K shall help GKV to develop and organize specialized programmes for training the faculty of GKV engaged in PG level teaching and research.
- ii. GKV would receive access to NITTTR-K's advanced in-campus laboratory facilities; the details of which would be jointly worked out.
- iii. NITTTR-K shall assist GKV in making reference materials (journals, thesis and so on) available for the PG work, wherever possible.
- iv. GKV and NITTTR-K shall identify from time to time, research areas for joint supervision of M.Tech programme.
- v. NITTTR-K and GKV shall identify from time to time research areas in the field of Educational Technology / Educational Management.

## 3.0 FINANCE

- 3.1 A Seed Corpus of Rupees Five Lakhs shall be created by GKV for meeting the initial TA/DA expenses etc. for parties.
- 3.2 The cost of running any of the items mentioned in 2.1.1 and 2.1.2 would be jointly worked based on these scope and deliverables and shall be borne by GKV. The details would be worked out on a case-to-case basis. [in this regard Table 1 given in Aannexure-1 may be referred to].
- 3.3 The mode of payment, including advance payment wherever, applicable, shall be mutually worked out.

## 4.0 INDEMNITY CLAUSE

GKV shall indemnify NITTTR-K from the risks of any liability through the various affiliated and constituent institutions of the former.

5.0 INTELLECTUAL PROPERTY RIGHT

The IPR created out of any joint research and learning shall be the common property of the Parties (NITTTR-K and GKV). The Parties can thereafter commercialize the IPRs on mutually agreed terms and conditions. However, existing IPRs prior to the MOU at the disposal of either of the Parties shall be excluded from any joint ownership.

6.0 PERIOD OR VALIDITY OF THE MOU

The MOU shall remain valid for a period of five years initially, starting from the date of signing the MOU. The MOU can however, be extended or terminated through mutual consent.

7.0 OPERATIONALIZATION OF MOU

Specific projects, as mutually agreed upon by the parties, shall be identified by GKV for assistance from NITTTR-K in which the scope and the deliverable of the specific project shall be specified. Further, the cost of the same, mode of payment and the time frame shall be spelt out on a case-to-case basis.

8.0 FORCE MAJEURE

Notwithstanding any item contained in this MOU, neither Party shall be held responsible for actions beyond their control (e.g., natural calamity, law & order situation and so on) and no compensation shall be claimed by either Party from other nor shall be paid.

9.0 ARBITRATION

In case of disputes arising out of or related to any of the clauses contained in the MOU, it would be attempted to resolve the same bilaterally.


