Recognize the mutual interest in the fields of Training and Placement, Awareness program, Consultancy and dissemination of knowledge

Recognize the importance of career counselling in shaping the career path of the candidates.

Recognize the importance of the Industry Partner within its field of expertise

The parties hereby agree to establish collaboration according to terms and conditions set out in the articles following hereunder.

Scope of Collaboration

The general purpose of this MOU is to facilitate industry and institute based upon the principles of mutual benefit and may include the following general cooperation areas:

- 1. Joint industry-academia and research activities.
- 2. Specific activities under this MOU will identified through consultation between the two parties. Aseries Envirotek agrees to provide specific assistance to Gurukula Kangri Vishwavidyalaya improving recruitment of their students with the use of their innovative solution. Aseries Envirotek will work with their clients to bring openings on its solution and all eligible students of Gurukula Kangri Vishwavidyalaya will participate for job interviews on the platform from their campuses.
- 3. As a preliminary activity, both Aseries Envirotek and Gurukula Kangri Vishwavidyalaya will appoint a coordinator for effective communication that will happen throughout the session. Then Gurukula Kangri Vishwavidyalaya will ensure all interested students download the android app and login using assigned

- 4. Time to time, Aseries Envirotek will bring campus recruitment opportunities on the solution and will communicate with Gurukula Kangri Vishwavidyalaya coordinator and TPO. Gurukula Kangri Vishwavidyalaya will ensure all eligible students participate in those interviews. Coordinator will share status report with Aseries Envirotek.
- 5. At times Aseries Envirotek may provide preparatory opening to students and Gurukula Kangri Vishwavidyalaya will ensure all students will participate in those interviews. Result of these interviews will be shared with Gurukula Kangri Vishwavidyalaya and TPO office will use it to give feedback to students. This feedback will be shared with Aseries Envirotek too.
- Gurukula Kangri Vishwavidyalaya agrees to work with and coordinate with Aseries Envirotek to improve
 and expand campus recruitments for their students. They also agree to allow Aseries Envirotek to
 interact and assess their students for campus recruitment related activities.

General Terms & Conditions

- This MOU is not intended to, and does not create any right, benefit, or trust responsibility, substantive
 or procedural, enforceable at law or equity, by either party, its officers, employees, or agents against the
 other party, its officers, employees, or agents.
- This MOU shall be operational upon signing and will have an initial duration of one year. All activities
 conducted before this date within the vision of the joint collaboration will be deemed to fall under this
 MOU
- 3. This MoU is solely work for the development of students, faculty, industry executives and staff community provides self-employment, training and skill development.
- 4. In order to carry out and fulfill the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities.
- 5. This whole engagement will be free of cost for Gurukula Kangri Vishwavidyalaya and its students. Both the party cannot charge any kind of commercial for their services to second party.
- 6. Each party agrees that after execution of the MoU, shall not disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.
- 7. The partnership covered by this MOU shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written one-month notice from either side. In the event of non-compliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.
- 8. Gurukula Kangri Vishwavidyalaya will allow Aseries Envirotek to use all reports, content for expanding services for benefit of students.
- In the event any company not willing to visit Gurukula Kangri Vishwavidyalaya for campus recruitment
 or no student is selected from Gurukula Kangri Vishwavidyalaya by company, Gurukula Kangri
 Vishwavidyalaya cannot hold Aseries Envirotek responsible for any liability what so ever.
- 10. All notice, demands and other communication under this agreement in connection herewith shall be written in English language and shall be sent to the last known address, email, or fax of the concerned party. Any notice shall be effective from the date on which it reaches the other party

- 11. Nothing in this MOU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the parties unless expressly stated in this agreement.
- 12. Both parties agree to submit outcomes of their joint collaboration, whilst safeguarding their own copyright and any patents that may produce by their collaboration.
- 13. The activities of this MOU must be carried out in accordance with appropriate laws and regulations existing in India.
- 14. Gurukula Kangri Vishwavidyalaya will promote ethical practice among students and encourage them to conduct ethically during interview and assessments.
- 15. In the event of legal/health/family situations of selected candidates, where student cannot join organization, TPO of Gurukula Kangri Vishwavidyalaya and /or coordinator will inform Aseries Envirotek giving all factual information.

The Agreement

- 1. At Gurukula Kangri Vishwavidyalaya, Registrar/Prof. In-charge CAOC will administer this MOU. At Aseries Envirotek, Mr. Amar Singh Yadav Designation Managing Director will administer this MoU.
- 2. The parties may enter into specific written agreements under authority of this MoU to clarify and define the nature, extent and terms of operation for the proposed collaborations, including intellectual property ownership and funding issues.
