## **CORRIGENDUM**

In reference to the amendment in the UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018 as **University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Amendment Regulations, 2021 published on 11.10.2021**, the mandatory requirement of Ph.D. for direct recruitment to the post of Assistant Professor has been extended from 1.7.2021 to 01.07.2023. A candidate who is not Ph.D. but fulfills other essential qualifications may also apply for the post of Assistant Professor.

In pursuance with the above amendment, all the candidates who could not apply for the post of Assistant Professor against the **Adv. No. GKV/Estt./01/2021** can now apply in prescribed format on payment of **Rs. 1200/- (Rs. 600/- for SC/ST/PWD)**. Application form can only be downloaded from the website [www.gkv.ac.in](http://www.gkv.ac.in).

Completely filled in application (06 copies) in a sealed envelope superscribed with **Adv. No.** and the **name of the post applied** should reach the office of the **Registrar, Gurukula Kangri (Deemed to be University), Haridwar- 249404 (Uttarakhand)** by **Speed /Registered Post** only.
