

# Frequently Asked Questions (FAQs)

## **Q 1. What are the courses offered in Faculty of Engineering and Technology, Gurukula Kangri Vishwavidyalaya?**

**A.** The Faculty of Engineering and Technology (FET), Gurukula Kangri Vishwavidyalaya (GKV) offers four-year regular course.

Bachelor of Technology (B. Tech.) in following streams:

1. Computer Science & Engineering – 115 seats
2. Electronics & Communication Engineering – 115 seats
3. Electrical Engineering – 115 seats
4. Mechanical Engineering – 115 seats

## **Q 2. What is the minimum eligibility criterion to get admission in B. Tech. in FET, GKV?**

**A.** The admission(decided by AICTE, APH 2021-22.) is open to all the male candidates who

1. Passed 10+2 examination with Physics/ Mathematics /Chemistry/ Computer Science/ Electronics/ Information Technology/ Biology/Informatics Practices/ Biotechnology/ Technical Vocational subject/ Agriculture/ Engineering Graphics/ Business Studies/Entrepreneurship.(Any of the three) Obtained at least 45% marks (40% marks in case of candidates belonging to reserved category) in the above subjects taken together.

OR

Passed min. 3 years Diploma examination with at least 45% marks (40% marks in case of candidates belonging to reserved category) subject to vacancies in the First Year, in case the vacancies at lateral entry are exhausted.

2. AIR of JEE Mains for Session 2021-22 conducted by N.T.A., New Delhi.

## **Q 3. What is the procedure of Admission in B.Tech. in FET, GKV?**

**A.** There are two ways in which one can get admission in B.Tech. course in FET, GKV

1. Admission shall be made in accordance with rules and regulations made by C.S.A.B./JoSAA through CML/AIR of JEE Mains – 2021.
2. After upgradation of the already admitted students remaining vacant seats will be filled through candidates by applying through form on the basis of AIR of JEE(Mains).

Application for B.Tech I year against vacant seats to be filled online on [www.gkv.ac.in](http://www.gkv.ac.in) and Registration Form along with required fee of Rs.500/- in the form of online transfer receipt should be sent to- [admissions.fet@gkv.ac.in](mailto:admissions.fet@gkv.ac.in).

**Q 4. Is there any fee for counselling for the vacant seat?**

A. Candidates shall have to deposit a demand draft of Rs. 1000/-(Non Refundable and Not Adjustable) as counselling fee in favour of the Registrar, Gurukula Kangri Vishwavidyalaya payable at Haridwar at the time of counselling for vacant seats.

**Q 5. What are the documents required for admission in B.Tech.?**

A. Candidates in the merit list have to come for counseling /admission along with the following original certificates /documents with 4 Set of photocopies & 8 Photographs.

- (i) High School Certificate & Marksheet
- (ii) Intermediate (10+2) Certificate & Marksheet
- (iii) Migration & TC from the institution last attended
- (iv) Character certificate from the institution last attended
- (v) Reservation category certificate, if applicable
- (vi) Score card & Admit card of JEE mains-2021

**Q 6. Is there any procedure for Admission in B.Tech. 2<sup>nd</sup> year in FET, GKV?**

A. Yes. Application for B.Tech II year against to be filled online on [www.gkv.ac.in](http://www.gkv.ac.in) and Registration Form along with required fee of Rs.500/- in the form of online transfer receipt, High School Certificate, Marksheet and Diploma/BSc. Marksheet should be emailed to [admissions.fet@gkv.ac.in](mailto:admissions.fet@gkv.ac.in)

**Q 7. What is the minimum eligibility criterion to get admission in B. Tech. 2<sup>nd</sup> year (lateral entry) in FET, GKV?**

A. A candidate must have passed the Diploma in Engineering in the any branch with a minimum of 60% marks (55% for SC/ST) in aggregate. OR A candidate must have passed the Degree in Science (B.Sc.) with Mathematics as a subject and with a minimum of 60% marks (55% for SC/ST and GKV graduates) in aggregate.

**Q 8. What is the procedure of Admission in B.Tech. 2<sup>nd</sup> year (lateral entry)?**

A. Admission shall be made on the basis of merit(*Diploma/BSc Marks*).

**Q 9. What are the documents required for admission in B.Tech. 2<sup>nd</sup> year (lateral entry)?**

A. For Direct Admission to B.Tech II year candidates have to produce following certificates

- (i) High School Certificate & Marksheet.
- (ii) Intermediate (10+2) Certificate & Marksheet.
- (iii) B.Sc./Diploma Certificate & Marksheet
- (iv) Migration & TC from the institution last attended
- (v) Character certificate from the institution last attended
- (vi) Reservation category certificate, if applicable

**Q 10. What is the fee structure of B. Tech. in FET, GKV?**

A. The fee structure for the batch 2021-2025 is as follows.

- Fee will be deposited in two instalments only preferably through online at the time of admission.
- Candidates taking Direct Admission to B.Tech. 2<sup>nd</sup> year will have to pay Rs.92050/- at the time of admission.
- No application shall be entertained for refund of security money after one year of completion of the course.

**Q 11. Is there any other fee need to be paid during the course?**

A. A student is required to deposit the following charges to obtain the mentioned documents

**Q 12. Whether hostel facility is available or not?**

A. Hostel facility is available in the main campus of Vishwavidyalaya for B.Tech. Ist Year students only against limited seats.

**Q 13. What is the hostel fee?**

A. The complete hostel fee details are as follows(*tentative*)

**Q 15. Does the admission to B. Tech. open to female candidates?**

A. No.

**Q 16. How does a candidate get confirmed about the selection in B.Tech.?**

A. Merit list of the selected candidates will be published on the notice boards at Registrar office and Faculty of Engineering & Technology. It will also be available on the university website. No communication will be done by post regarding the admission.

**Q 17. Can a candidate admission be cancelled after allocation of seat?**

**A.** The Admission of the candidate shall be cancelled if the information given by the candidate is found false/incorrect or not fulfilling minimum eligibility at any stage, during or after admission.

Candidates appearing in the final year of qualifying examination shall have to produce their result upto 15 October, 2021 failing which their admission shall be treated as cancelled.

**Q 18. How many seats are reserved for reserved category students?**

**A.** 27% OBC, 15% SC, 7.5% ST, 10% EWS and 5% vertical reservation for PWD (differently abled person)

**Q 19. Does the institute have any other quota of seats?**

**A.** Yes. There are Prime Minister's Special Scholarship Scheme (PMSSS) category seats for J&K students which is directly filled by AICTE whose details are as follows.

1. Computer Science & Engineering – 4 seats
2. Electronics & Communication Engineering – 2 seats
3. Electrical Engineering – 2 seats
4. Mechanical Engineering – 2 seats

**Q 20. Does institute give any type of fee relaxation to minorities or EWS?**

**A.** No fee relaxation to EWS. Only the hostel fee for SC and ST candidates is to be taken as Rs. 13000 in place of Rs. 18000, other particulars remaining the same. The scholarship may be provided according to the state government rules in which state the candidate belongs.

**Q 21. What is process of applying for scholarship?**

**A.** Students can apply under various Scholarship schemes of their State or Central government schemes as per their eligibility. The SC/ST Cell of University facilitates such applications from Gurukula Kangri University.

**Q 22. Can I take admission in general category if belong to other category?**

A. Yes, according to merit.

**Q 23. Do I have to pay the fee in one installment or can I pay in several instalments**

A. Fee has to be deposited as per payment schedule mentioned in Admission Brochure.

**Q 25. What is the process of changing the branch after first year?**

A. Change of branch depends on JEE main merit and thereafter on basis of first year marks and finally on the availability of seats in second year i.e. 5% of the intake and vacant seats in second year.

**Q 26. What is process of submitting documents?**

A. Documents are be deposited at the time of seat allotment.

**Q 27. When will I be called to the institute, if I lock my choice as “Gurukula Kangri Vishwavidyalaya” in CSAB counselling rounds.**

A. CSAB/JoSAA shall announce the date for that candidate inform him accordingly.

**Q 28. Do I have to show the domicile of the state to take admission in GKV?**

A. No.

**Q 29. If I got admission in electronics and want to change to electrical or any other branch, what is the process and what are my chances?**

A. Change of branch can be done in second year on the basis of first year marks or/and in first year upgradation on the basis of JEE mains rank.

**Q 30. If I fail to pay for exam fee on time would my admission be cancelled?**

A. In our counselling examination fee will be deposited at the time of seat allotment. Without examination fee, exam form will not be processed.

1. If Student is allotted a seat through JoSAA/ CSAB 2021 and got admitted at Gurukula Kangri University but left the university:
