Subject: Recognition of Vidyadhikari equivalent to
 Matriculation.

Sir,

With reference to your letter No.18-418 A/1240/
 C.P. dated 15.6.1982 I am directed to say that in this
 Ministry's O.M. No.6/10/82-Estt.(D) dated 17.11.1962
 the diploma of Vidyadhikari awarded by the Gurukula
 Vishwavidyalaya, Kangri, was recognised as equivalent to
 Matriculation though for a limited period. The extension
 of this recognition has not become necessary in view of
 the subsequent instructions issued vide this Department
 O.M.No.6/1/64-Estt.(D) dated 10.4.1964 according to which
 in the case of diplomas awarded by educational institutes,
 inter alia, declared to be deemed as Universities under
 section 3 of the University Grants Commission Act, 1956,
 no formal orders recognising such diplomas need be issued
 by the Government, such diplomas are recognised automatically
 for the purpose of employment by the Central Government.
 Since Gurukula Kangri Vishwavidyalaya has been recognised
 as a deemed University vide the Ministry of Education
 notification No.10-17/62.U 2 dated 19.6.62 the diplomas of
 Vidyadhikari awarded by Gurukula Vishwavidyalaya would be
 recognised automatically as equivalent to Matriculation by
 all Ministries of the Government of India.

2. It is not considered necessary to issue another
 communication confirming this as all Ministries/Departments
 since they are expected to take note of these instructions.
 If, however, any case comes to the notice of Gurukula
 Vishwavidyalaya expressing any doubt in this regard, a suit-
 able clarification may be given in the light of the position
 explained above.
