MEMORANDUM OF UNDERSTANDING

BY AND BETWEEN

Gurukula Kangri (Deemed to be University) having its address at Haridwar PIN 249404 Uttarakhand, represented herein by its Vice-Chancellor, Prof. Roop Kishore Shastri (hereafter referred as 'First Party/the institution' which expression, unless excluded by or repugnant to the subject or context shall include its successors—in—office, administrators and assigns).

AND

Anand Prakash Yoga Ashram Trust, a Trust registered in India, having its address at Tapovan, Shivananda Nagar (Rishikesh) Pin-249192, Tehri Garhwal (U.K) India. (Hereinafter referred to as 'Second Party', company which expression, unless excluded by or repugnant of the subject or context shall include it successors—in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as Party')

WHERE AS:

A. First Party is a Deemed to be University which was founded on 4th March 1902 by the Arya Samaj Sanyasi Swami Shraddhanand who was follower of Dayanand Saraswati with the sole aim to revive the ancient Indian Gurukula system of education. It is one of India's oldest leading education, development and philanthropy foundation comprising universities, higher education institutions, schools, academies and centres of research and excellence. This Institution was established with the objective of providing an indigenous alternative to Lord Macaulay's education policy by imparting education in the areas of vedic literature, Indian Philosophy, Indian culture,

Both Parties, desire to sign an MOU for advancing their mutual Interests;

NOW THEREFORE, in consideration of the premises and intending to be legally bound hereby, the Parties agree as follows:

CLAUSE-1: CO OPERATION

- 1.1 Both parties are united by common interest and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2. First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable students training systems.
- The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE-2: SCOPE OF THE MOU

Trainings Workshops and Conferences: The Second Party will conduct certificate 2.1 course for the students of Yoga. Both the Parties shall cooperate each other and jointly organise certificate course, training, workshop and seminar.

will provide consultancy to the Second Party to include Vedic aspects of Value in their curriculum. will help the second party to design courses which can provide employment

of in various industries and organisations in the field of Value Education.

Lectures: Second Party will extend the necessary support to deliver guest rs to the students on the moral value education. First party will not beer any inancial burden.

- Faculty Development Programmes: Second Party may train the Faculty of First Party 2.5 for imparting moral and value education.
- 2.6 Participation in Events: Students and Faculties of the First Party shall be allowed to participate in the events, activities conducted by the Second Party to further facilitate the inculcation of values and morals.
- There is no financial commitment on the part of Gurukula Kangri (Deemed to be 2.7 University), and Anand Prakash Yoga Ashram Trust to take up any programme mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

CLAUSE-3: VALIDITY

- This MoU will be valid for five years or until it is expressly terminated by either Party.
- 3.2. Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In the events of Termination, both parties shall discharge their obligations accrued before the termination. This MoU may also be terminated anytime by the mutual written consent of the parties.

CLAUSE-4: RELATIONSHIP BETWEEN PARTIES

Prakash Yoga Ashram Trust (Second Party) are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party, except for the purposes as agreed herein. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

CLAUSE-5: DISPUTE SETTLEMENT

Any divergence or difference derived from the interpreta ion or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at Haridwar, Uttarakhand. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction of the Courts at Haridwar except jurisdiction for any injunctive relief, which shall lie to appropriate courts having jurisdiction.
