General conditions for Junior Research Fellow

- Professionals with requisite qualifications and experiences as prescribed would be eligible being for engaged as JRF, However, if suitable NET/GATE qualified candidates are not found, the candidates without these qualifications may be considered for Project Fellow as per the DST (SERB) approved fellowship rates.
- 2. JRF/ Project Fellow would be engaged for a fixed period for providing high quality services to the project or for attending to specific and time-bound jobs.
- 3. The appointment of JRF / Project Fellow would be on Full-time basis and they would not be permitted to take up any other assignment during the period of project with the GKV, Haridwar.
- 4. The appointment of JRE/ Project Fellow is purely temporary on co-terminus basis and do not entitle the appointee to any claim implicit or explicit or any post. The appointment can be cancelled at any time by the GKV, Haridwar without assigning any reason.
- 5. The initial term of appointment and subsequent extension (s) if any, shall be decided on case to case basis depending upon the specific jobs as per progress report and the time frame for its completion.
- 6. The JRF shall not be entitled to any allowance such as Dearness Allowance, Residential, Telephone, Transport facility, Personal Staff etc.
- 7. The selection of candidates will be made through Walk-in-Interview by selection committee. No TA/DA will be paid to the candidate for attending the interview.
- 8. Candidates can directly attend the walk-in- interview on the prescribed date, time, and place at GKV, Haridwar along with complete bio-data, passport size photograph and original proof of qualifications and experiences. They must also bring with them self-attested copies of their certificates. Candidate may report in GKV, Haridwar 0:30 hours before the Interview time. After starting of interview, admission in the same will not be allowed.
