



About First Party:

Gurukula Kangri (Deemed to be University), Haridwar was founded on 4 March 1902 by the Arya Samaj sannyasi Swami Shraddhanand Ji, who was a follower of Dayananda Saraswati Ji, with the sole aim to revive the ancient Indian Gurukula system of education. This institution was established with the objective of providing an indigenous alternative to Lord Macaulay's education policy by imparting education in the areas of Vedic literature, Indian philosophy, Indian culture, Modern sciences and Research.


About the Second Party:

Uttarakhand Sanskrit University was established on April 21, 2005 based on the recommendation of the Sanskrit Commission (1956-57) proposed by the Government of India to upgrade Sanskrit Education in Uttarakhand region. 





- Organizing joint seminars, workshops, conferences etc.

 - Consideration and acceptance of Credits earned by the students for their academic degrees.

- This MoU is effective from the date when both parties have signed it.
 - The MoU is open to modifications or amendments as per the future mutual requirements between both the parties. No amendment to this MoU shall be valid or binding unless set for in writing and duly signed by both the parties.
 - This MoU shall be initially valid for three years from the date of signing and to be extended subsequently for further period on mutually agreed terms and conditions.
 - Nothing in this MoU authorises a party to use the name, logo or any trademark of the other party or its employees in any advertisement, press release or for other similar means without prior approval.
 - Nothing in this MoU is intended to create a legal partnership or joint venture between the parties.
 - In the case of either party wishing to discontinue/terminate the MoU within the period of its tenure, they shall do so by giving a one month (30 days) advanced notice.


