**Subject: Admission to M.Sc. Chemistry for Session 2026-2027.**

Dear Candidate,

In reference to your application for admission to **M.Sc. Chemistry** your name appears in the merit list. You are required to report online/offline on **30.05.26 between 10:00 AM to 12:00 PM** in the Department of Chemistry, G.K.(DU), Haridwar for counseling with the following documents:

1. Admit card of entrance examination ( Original Copy)
2. Attested copies of High School Certificate or equivalent examination
3. Attested copies of High School Mark sheet or equivalent examination
4. Attested copies of Intermediate (10+2) Mark sheet or equivalent examination
5. Attested copies of Mark sheets of all the years of graduation (if applicable)
6. Character Certificate ( Original Copy)
7. Migration Certificate ( Original Copy)
8. Attested copies of Reservation Category Certificate (OBC reservation category certificate must be in the Central Govt. format)
9. Six Passport size photographs
10. Original copy of all the above Certificates / Documents/ Mark sheets ( for verification)

**Note :**

1. In case the result of graduation final year of the candidate has not been declared yet, attested copies of Mark sheets of the graduation I & II years are to be submitted and the candidate will have to submit an undertaking at the time of admission that he/she will submit the Mark sheet in accordance to the eligibility condition of his/her final year examination latest by **30 October 2026**. In case he/she fails to submit the final year Mark sheet by the due date, his/her admission shall stand cancelled automatically and he/she will not be entitled to claim the refund of the paid fee.
2. In case of study gap or any reason, the candidate will have to submit an undertaking at the time of admission giving appropriate reason.
3. The reservation category certificate should be in accordance with the guidelines of Central Government. Accordingly, the creamy layer shall not get reservations in Central OBC category. The candidate shall be granted admission subject to verification of his category certificate.

**In case you fail to turn up on 30.05.26 between 10:00 AM to 12:00 PM your claim for admission will be forfeited.**

**You are required to pay Rs. 1100/- as Counseling/ Processing fee (non refundable)** through the link which will be sent to you separately through sms the mobile number mentioned by you before 30.05.2026.

You will have to submit the admission fee of Rs. 33150/- immediately after confirmation of your admission during counseling, another link will also be sent to you on your mobile number for the final fee submission. Fee submission permissible only by online mode.

2. **Counseling/Processing fee (non refundable) as well as admission fee shall be deposited.**
3. Counseling may continue on the next day if required.
4. Error, if any, subject to rectification.
